THE HALF-EARTH PROJECT IS: 1) DRIVING RESEARCH TO BETTER UNDERSTAND OUR WORLD, 2) PROVIDING LEADERSHIP TO GUIDE CONSERVATION EFFORTS, AND 3) ENGAGING PEOPLE EVERYWHERE TO PARTICIPATE THIS GLOBAL AMBITION.
